Asian PGPR Society for Sustainable Agriculture (APSSA) - 2020

Fellow of Asian PGPR Society for Sustainable Agriculture (FAPSSA)

Objective

The objective of APSSA is

- 1. To recognize and support the excellence research, teaching, technology development and innovations, commercialization, and technology development in the field of sustainable agriculture.
- 2. Outstanding achievements and sustained and significant contributions that impact the agriculture sciences are the main objectives.
- 3. To recognize distinguished academicians who have made outstanding contributions to research, teaching, technology development, patenting, commercialization and/or technology transfer including publications in any of the basic or applied areas sustainable agriculture.

Criteria for Election of Fellows

- 4. APSSA fellows will be recognized based on their excellence in the field of sustainable agriclture and allied fields.
- 5. The elected person will be called as Fellow of Asian PGPR Society for Sustainable Agriculture; and will be entitled to use the title FAPSSA
- 6. The total number of the Fellows of the Academy elected in a year at any given time shall not exceed 04.
- 7. Nominations of FAPSSA are to be made in following fields
 - [A]. Crop Sciences
 - [B]. Horticultural Sciences
 - [C]. Plant Growth promotion, stress tolerance and Plant Protection Sciences
 - [D]. IPR, Patents and Commercialization aspects of PGPR and allied technology
- 8. A person elected as Fellow of APSSA shall be presented a citation during Asian PGPRconference
- 9. Nomination once made will remain valid for next three years and his/her biodata will be updated every year.
- 10. These rules and regulations will be effective from the year of Registration and tentatively w.e.f. 01st August 2020

Eligibility Criteria

- 1. An outstanding contributions to research, teaching, technology development, commercilization, Patenting and technology transfer including publications in any of the fields of agriculture.
- 2. All members of APSSA having standing of five years as life member are eligible for nominations as APSSA Fellows.
- 3. An outstanding researchers from any International research organization/reputed foreign university can be considered for the election as Fellow, even if he/she is not member of the Academy. However, at the time of election, he/she has to be enrolled as life member of APSSA. The number of such fellow shall be restricted to two in a year.
- 4. Doctoral degree (Ph.D)
- 5. Minimum of 10 years of research/teaching/technology development experience in any branch of agriculture or allied science.
- 6. Should have proven academic-Research record as proved by publications, patents, Technology development, technology transfer, popular talks.
- 7. Should be in the active services in state/central government Universities/institutes or research government or private organizations.

Nominations

- **1.** The nomination for a Fellow should be proposed and seconded by either a Fellow of APSSA or Life member of APSSA for last FIVE years.
- 2. A life member of APSSA can propose up to TWO nomination in a year.
- **3.** Nomination should be made in the prescribed proforma which may be downloaded from the website of society.
- **4.** Nomination duly proposed and completed in all respects should reach APSSA by the last date notified on the society's webste asianpgpr.com.

Selection and Election of Fellows:

- The Executive Council (EC) of APSSA will constitute a panel of Four experts including the Convener, and Three member.
- The Convener will forward the eligible nominations to other Members of the Committee and seek their recommendations in accordance with the marking guidelines developed by APSSA. The Convenors and members Committees will meet and compile the recommendations.

- Recommendations duly compiled by the Conveners will be placed in E.C. meeting, which will approve the nominaions and the elected nominee will be awarded the APSSA Fellow award during APSSA conference.
- The decision of EC will be final and subject to no judicial review.

Conferring of the Fellowship

- The final recommendation of the E.C. regarding the election of a nominee as a Fellow of APSSA will be communicated by General Secretary and the candidate will be invited for conferment of the fellowship.
- The fellow or his/her institute will bear the travelling expenses for this purpose.
- In a Special Session of the Annual Meeting of APSSA, the elected Fellows will be conferred the Fellowships, along with a citation and memento
- The recipient of fellowship will make a brief presentation of his/her significant achievements.

Right and privileges of FAPSSA

- The fellow will be entitled to use FAPSSA after his/her name as a short title. The title FAPSSA once conferred will remain for the lifetime of the member. However, if any fellow of APSSA is found to be involved in any unlawful activity, perjury or any other act prejudicial to the interest of APSSA, APSSA will take up the issue and will decideabout dismissal/derecognition of fellowship/Membership.
- Fellows of the Academy will continue to have all the rights and privileges of Member of Academy.
- Fellows of the Academy will have the privilege of nominating APSSA life members for election of the Fellow of APSSA.
- Fellows who have retired from active service may be exempted from paying registration fee while attending National Conferences of APSSA, but he/she will have to intimate the organizing seretary of the conference.

Nomination Format for Election of Fellows of APSSA

Important Instructions

- 1. Duly completed nomination Proforma should **be sent by Registered Post/Courier** Service/ by Hand either by the Proposer or Seconder of Nominee to the **General Secretary**, APSSA, so as to reach on or before the last date specified by APSSA.
- 2. "Nomination for Selection of Fellow" should be written on the envelope containing the nomination papers.
- 3. Both the Proposer as well as the Seconder must sign the nomination Proforma.
- 4. Both the Proposer as well as the Seconder of the nomination should either be FAPSSA or Life Member of APSSA for the last FIVE years.
- 5. Research publication in peer reviewed and refereed journals National and International Journals only may be listed.
- 6. Ten most important publications with their Impact Factor and Citation index should be mentioned and front page of each paper should be sent to the society.
- 7. One set of the cover page of the important books/monographs/manuals published with should be enclosed.
- 8. All the columns in the Proforma should be typed.
- 9. Complete nomination proforma, including the PDF of 10 best papers, must accompany with the Nomination.
- 10. Nomination with incomplete information will be returned to the nominee with copy to the proposer and shall not be considered for processing for its evaluation.
